The Apple II public domain disk-of-the-month was "Quick-View," Mark Munz's free AppleWorks word processor file reader that lets you read any AppleWorks word processor file without booting AppleWorks. QuickView is freeware and is of special interest to software developers and owners of 5.25 inch floppy disk systems. QuickView offers features not available in other file readers, including support for the Apple-1 through Apple-9 commands that let you scroll to different sections of the document. RNAUG's Beagle Buddy received this program from Lee Dronick, the Beagle Bros.

Alex Siegfried volunteered to select freeware/shareware programs for the Apple II disk-of-the-month for the January 1992 meeting.

Door prizes at the December meeting included 4 sets of Apple logo stickers, an Image II SPEED PAD Mouse Control Pad complete with a quick reference template of system helps for the Macintosh (donated to RNAUG by Amextra GmbH), three RNAUG pens, and one "super" door prize--an Apple HD disk drive, donated to the club by Don Wilder. Congratulations to John Wothe, who won the disk drive!

Doug Hazen suggested that the club purchase video's to either show at meetings or have available for members to sign-out (or both). Videos could be a "how to do" or use various programs. [Based on Doug's suggestion, the club recently ordered the "QC Video" by Quality Computers]. The QC Video will cost the club only \$5.00 and contains about 50 minutes of product news and reviews. It shows products in action--before you buy. You'll see the Quickie scanning graphics and words; watch as QC shows how to install memory cards; see how a hard-drive dramatically improves the performance of your system; and see actual screen shots of your favorite programs. The QC Video also shows you some of the inside workings of Quality Computers.

Following the general meeting, Paul Naro provided a LightingScan demonstration. Many members, myself included, did not get to see Paul's demo (the lights were dimmed since we were watching the User Group Connection's Fall 1991 video of the latest Apple Computer products). Although we did not get to see the entire video because of time constraints, there are some awesome new products available, including the Apple OneScan, a new scanner with over 250 shades of gray. Very impressive! Cost: \$1000 (including software). See the OneScan in action at the January 9th meeting. According to Mike Vargo, the OneScan will work with both the Macintosh and the Apple II since it uses a SCSI interface.

This concludes the minutes of the December 1991 general membership RNAUG meeting. Hope to see you at our next meeting, which is scheduled to begin at 1915 hours, January 9, 1992.

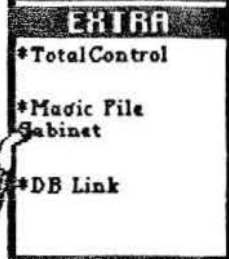

PRODUCT NEWS & UPDATES

Several products currently on the market are designed to expand available text in the AppleWorks 3.0 Data Base by linking Word Processor documents to Data Base categories.

The Magic File Cabinet by Magical Software, DB Link by Steve Beville, and TotalControl by JEM Software are the three examined here. In this article we attempt to provide a little information to help the prospective buyer know what he can expect from each one. First we briefly describe each product, and then we summarize some of the advantages and disadvantages of each.

DB Link 4.0 by Steve Beville

DB Link originally appeared on TimeOut MacroEase, the first of these products to give users extended Data Base text. Steve has since enhanced this macro program and created a TimeOut application out of it for easy access.

DB Link allows links to Word Processor files, Spreadsheet files and even other Data Base files. To set up a link, you enter the link file's pathname (usually a Word Processor file) in the last category of the Data Base record. Another category is then named starting with an asterisk, such as "*Info" or the like. This category contains the information you wish to search for.

To use DB Link, select it from the TimeOut menu and pressing SA-S to search for the link file on the desktop, on Triple Desktop, or on disk. When the file is found, it is searched for the specified info which is then displayed. At this point you may read or edit the info, and use SA-T to toggle back and forth between the original file and the linked file.

To automate the process of setting up links, DB Link includes a macro which lets you pick the link files from a disk listing, and then

automatically enters the correct pathname into the original file. It also has an option for naming the search categories by adding or removing the asterisk as needed.

DB Link operates with the screen off for minimal screen flashing, resulting in a "clean" looking product. It is the only one of the three programs that can link Data Base and Spreadsheet files, and is the only one that can automatically load the necessary files from disk if they're not on the desktop.

DB Link normally costs \$15 list plus s/h. A special discount is being offered to TO-C and NAUG subscribers. They can get DB Link for \$10 plus \$2 S/h in the U.S., \$3 to Canada, \$5 other. First class postage. Order from:

The Magic File Cabinet by Gary Hayman

The Magic File Cabinet (MFC) is based on a reference number in each data base record being used as the link to a corresponding reference number in a Word Processor file. The reference number must be in the first category displayed on screen so you must be careful with custom layouts. A BA-N macro automates entry of the reference numbers.

When SA-F is pressed in the Data Base, MFC switches to a Word Processor named the same as the Data Base file except that it starts with "W." The file must have been added to the desktop by the user. MFC does a find for the reference number in the Word Processor file and leaves the cursor there, ready for you to view or edit. You may then press SA-G to go back to the Data Base.

If the reference number is not found in the linked Word Processor file, MFC will create one automatically. While MFC is the least powerful of the three products, that probably makes it the simplest as well. It comes with the most documentation and ideas.

Several macros automate operations. For example,

BA-P - will print DB category cell information into the WP file.

BA-E - will position the cursor at the bottom of the individual WP entry to allow immediate addition of information.

BA-D - will allow automatic deletion of both the DB record and corresponding WP text material.

The Magic File Cabinet retails for \$15 plus \$2 shipping and handling (MD residents add .85 tax). TotalControl 2.0 by Randy Brandt & Dan Verkade

TotalControl 2.0 is a major enhancement to the AppleWorks 3.0 Data Base. The Word Processor Window is just one of many features. Pressing OA-W instantly displays a portion of a Word Processor file without actually leaving the Data Base file. The user may then scroll or page through the file. A macro on the disk allows you to press SA-J to jump into the Word Processor at the specified point so the file can be edited. Another SA-J returns you to the Data Base file.

Any category can be linked to a Word Processor file on the desktop, so you aren't limited to one Word Processor entry per Data Base record. The Word Processor file may be broken into sections using a Set Marker 150 command, which keeps the user limited to that section while viewing the file.

The OA-W command allows you to specify any Word Processor file name, or you may just give the information to search for and TotalControl will look for a Word Processor file with the same name as the Data Base except for a leading "H."

An additional OA-` command searches for a section with the same name as the category name. This allows help information generic to the category, as opposed to the record-specific info given by OA-W. For example, TotalControl's formulas are explained by a documentation section for each category, describing the formula contained in that category. TotalControl is the only product that doesn't leave the Data Base file, unless you actually want to edit the information, providing maximum speed.

A demo version of TotalControl is planned for an upcoming meeting.

TotalControl retails for \$60 plus \$3 shipping and handling. Through February 1, 1992,

Advantages

DB Link

- automatically loads files from disk
- links Data Base and Spreadsheet files

Magic File Cabinet

- many examples and ideas in documentation
- simplicity of use

TotalControl

- every category in every record can be a link
- no special macros are needed to view links

Disadvantages

DB Link

- only one link per record
- because it uses the Word Processor OA-F

Find command, false finds can happen in large files unless data set up carefully

Magic File Cabinet

- only one link per record
- Word Processor file must contain reference numbers
- no Triple Desktop support
- restricted to Word Processor files only

TotalControl

- you must purchase entire package, not just link feature
- restricted to Word Processor files only

Summary

DB Link and Magic File Cabinet are products with similar goals, priced the same. DB Link is a more sophisticated UltraMacros program and is much more powerful, but slightly more complicated to use.

TotalControl is a much different product because of its overall scope, but it offers some very similar features with its own unique benefits.

Check out the features you're interested in, try the demos, and enjoy extending the power of your Data Bases no matter which product you choose.

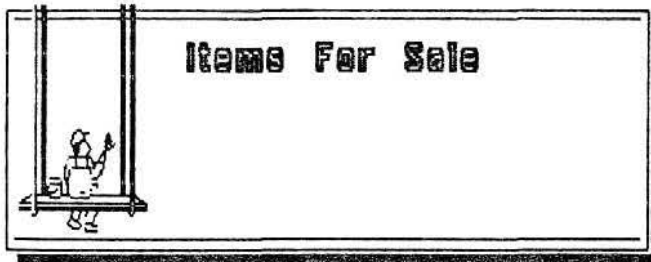

ClarisWorks Demo

Recently, while hunting for anything of interest on GEnie, I discovered a demo version of ClarisWorks. I decided to download it so I could play test to see if it was worth buying .

ClarisWorks contains five different modules; Word Processor, Data Base, Spreadsheet, Drawing, and Communications. In the interests of space, Claris left the Communications module out of the demo program. Having no documentation available and not being very familiar with Claris' other products, I had no problems getting around.

File Compatibility shouldn't be a

problem due to ClarisWorks using XTND technology to handle the file translations. According to reports, ClarisWorks is shipping with 20 translators. This should handle any file problems that may come up. I took a drive down to the Patch Barracks Audio Photo Club over the Christmas Holidays and discovered that while they don't have ClarisWorks available for sale, they are bundling it with the PowerBook100 and the LC.

Critique: Very Stable; blows away Microsoft Works . You can change from one module to another by clicking on a tool in the toolbar. Relatively fast. In short... Pretty awesome for an integrated product. The only problem I had was with pasting a QuickTime

video into it. While it would paste anything else I could come up with, it would only paste the first PICT. Clicking on the movie icon to run it had no effect. I had no problem pasting the same movie into MS Word or MacWrite II on a friend's machine. Other than that minor problem, (it may work with the full-blown version) it's ease of use in getting around through the various modules is unsurpassed to date. It's too bad Claris (or Apple) had to wait so long to give Microsoft Works a run for their money. In my opinion, ClarisWorks is an excellent value and continuing with a tradition of fine products, Claris has once again produced a winner.
